DGL Powder Coatings have a comprehensive product stewardship programme to ensure that all products are monitored for chemicals of concern in line with leading international directives. This includes compliance to China RoHS 2.0.

What is the China RoHS 2.0?

The Chinese Ministry of Industry and Information Technology (MITT) published China RoHS 2.0 (called the Administrative Measures for the Restriction of the Use of Hazardous Substances in Electrical and Electronic Products on Jan 21, 2016, with it coming into effect on July 1, 2016. China RoHS 2.0 restricts the same six substances as EU RoHS 2. This list currently detailed below together with the maximum concentration permitted of these substances:

Substances	Maximum Concentration Permitted
铅 (Pb)	0.1%
汞 (Hg)	0.1%
镉 (Cd)	0.01%
六价铬 (Cr VI)	0.1%
多溴联苯 (PBB)	0.1%
多溴二苯醚 (PBDE)	0.1%

Thus based on the information currently available, we believe that DGL powder coating products meet the requirements of the China RoHS 2.0.

NOTE 1: DGL do not test for the presence of trace amounts of these substances that may be introduced into the product as a contaminant.

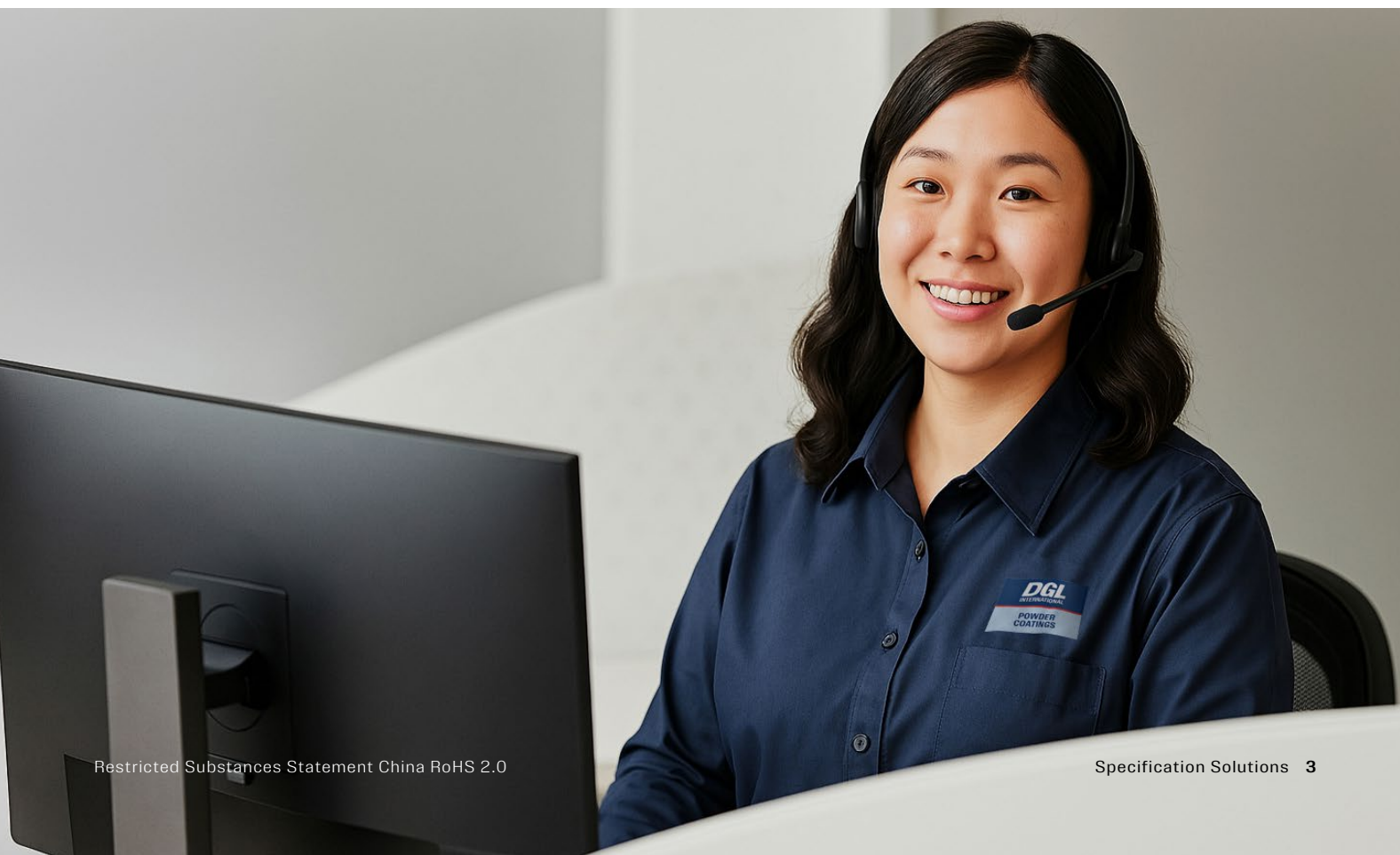
